


Barriers to Patient Flow Workgroup in VT

- Hospitals in Vermont were experiencing unprecedented patient placement challenges resulting in acute care patient capacity issues
- This group was established with primary stakeholders from DAIL, VAHHS, VHCA, VDH and VHEPC to discuss short term, longer term, and ideal future state of patient placement for the state of Vermont

 - o Dialysis

 - Behavioral Health/ Mental Health Needs
 - Patients/Residents receiving (Medication-Assisted Treatment) MAT
 - Unstable Financial Backing

 - Mental Health Issues
 - MAT Patient
 - Pending Medicaid Application Approval
 - Department of Corrections and/or patient has history of criminal convictions
